You clearly had a major party here with more than 5 guests, evidenced by the 7 empty 24pks of beer left on the porch and the dozens of cans littering my front bank. There are smashed glasses and soda bottles and used cigarette butts all over the porch and ground below. There is red wine spilled everywhere on the hardwood floors. 4. Water found sitting in between cast iron layers of stove, between body and lid of stove.















Lopi Leyden Wood Stove Details:


